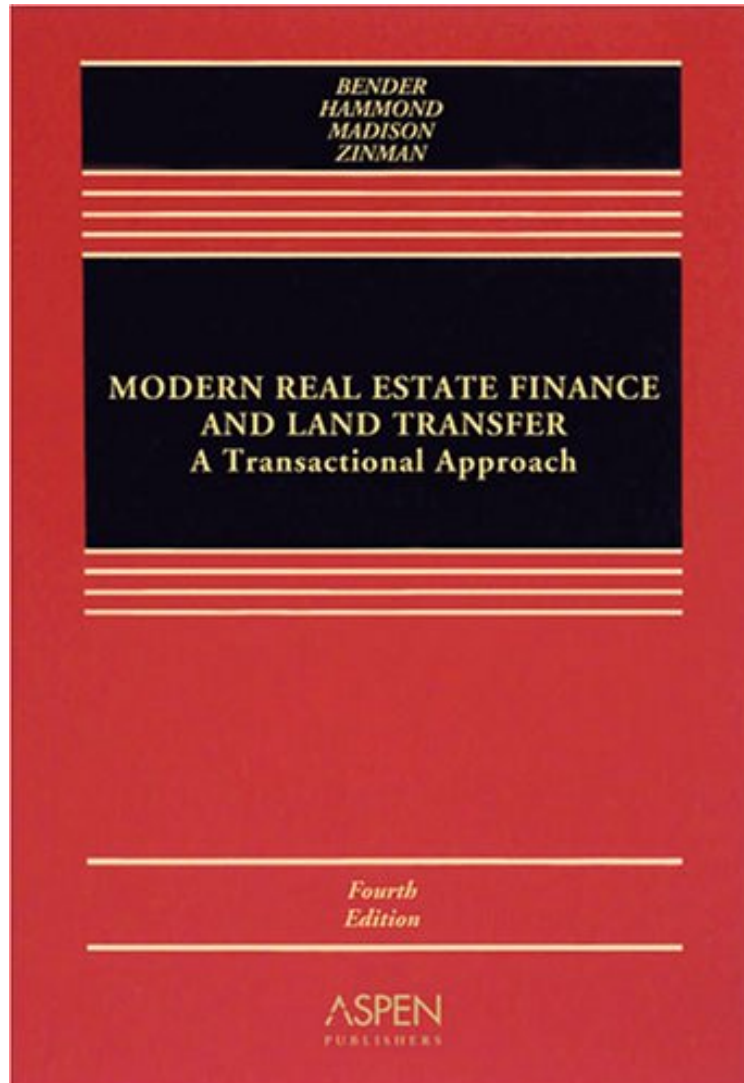

Also, lowered the price on the book by about \$10 right after shipping the book to me--I felt I should have been able to take advantage of that price within a certain time after shipping--similar
