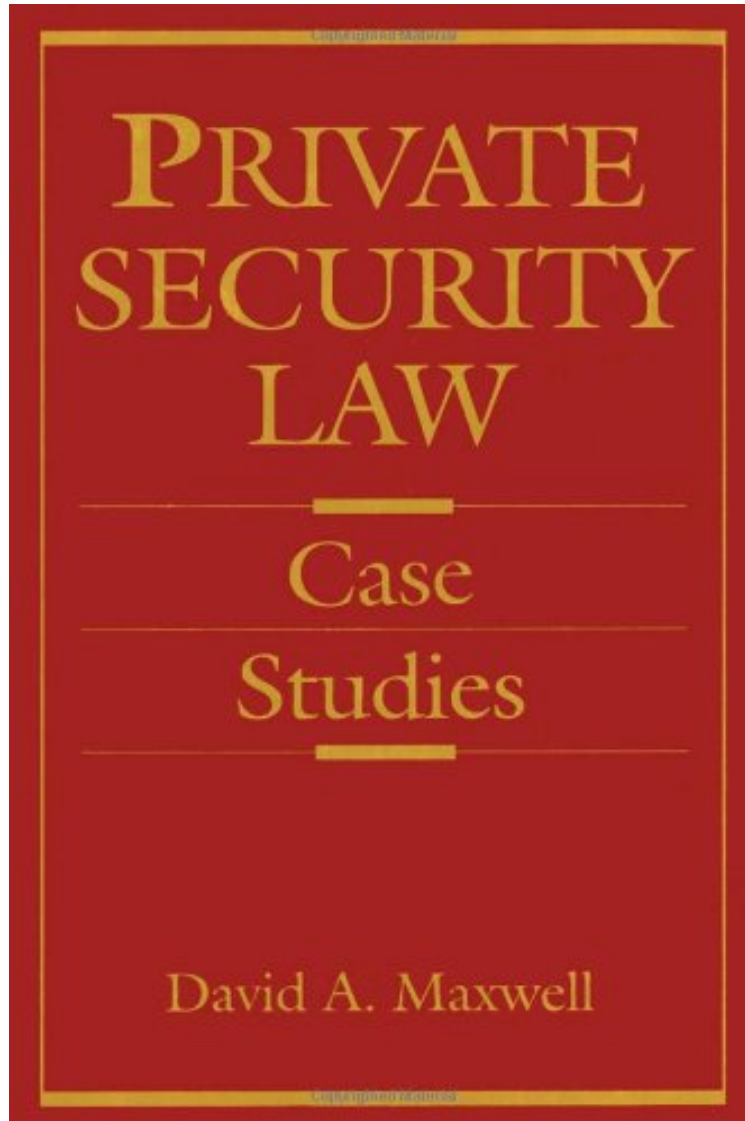

However, without a recent update or new edition, the example cases are now sadly out of date. In addition, newer topics in the area of cyber-security and updated laws on the regulation and powers of private security personnel are not addressed in the text. Use of this text now requires considerable work by the professor to bring in new materials and update nearly twenty years of case law decisions.
